

Mr. Siver is able to be up in a chair for part of each day but needs help in walking since he fractured a hip about a year ago. Mrs. Siver, who goes to see him frequently continues to live on the farm which she and her husband operated prior to their retirement a number of years ago. She is able to do her own housework but her son Arthur and his family, who live on the same farm, look in on her every day.

Cora Etta Manly and Allen James Siver, the latter a native of New

York state, were married Feb. 26, 1891, in the home of the bride's parents north of Mechanicsville. They were engaged in farming all their active lives. Mr. Siver is 89 years old and his wife is 89.

Mr. and Mrs. Siver have three sons, James Otis and John Allen of Mechanicsville, and Arthur T. of Martelle, who live on adjoining farms. They also have seven grandchildren, 15 great-grandchildren, and four great-great-grandchildren.

Mrs. Siver's family, the Manlys, who are scattered throughout the United States, have kept in touch by means of a "round robin" letter, which makes the rounds every few months. The picture of the Sivers, taken on the porch of the rest home, was included in the last letter sent to members of the group.

From Anamosa To Fairview, Road To Fame--Old 151

Some time ago an article appeared in Look Magazine about a street in Boston named "Fame" because of the people with a national reputation who had lived on this street at some time. Some of these people were Harriett Beecher Stowe, Benjamin Franklin, Dwight L. Moody.

Along the road from the Wapsipinicon bridge after leaving Anamosa, through the woods to Fairview and to Fairview, there have been quite a few boys born and reared who have become prominent and gained a national reputation.

There were two who became lawyers and bankers, a prominent doctor, the world's finest penman, four ministers, one of whom was the highest paid minister in the United States in his time, two judges, a missionary to China for 43 years, and another physician and surgeon. And so these few miles of the Old Military Road, now United States highway 151, could well be called a "Road of Fame." (Editor's note: The road is now a county pavement, commonly known as old 151)

However, to begin with, it will be necessary to tell that at the end of the bridge crossing the Wapsipinicon river out of Anamosa, Iowa, a man by the name of John Campbell built a house, which was razed only three or four years ago and weeping willow trees now grow in that spot. These beautiful willows might be weeping over the conditions

This article was written by the late John Bodenhofer, former Jones county supervisor and sheriff, who was born and raised on the Fairview-Anamosa road. Mr. Bodenhofer was the father of Mrs. Hylah Tonne, who found this manuscript with his things after his death at age 90, ten years ago. We are indebted to her for sharing it with us, and with you.

This was written more than 10 years ago, and of course then have been changes since the article was written also.

which existed there during the early 70's and 80's. A saloon and gambling house, was kept by John Campbell. It was hardly safe to travel this stretch of the road, especially on a Saturday afternoon or evening, because of the drunks and people who gathered at that saloon.

After we leave this spot on the Road of Fame, the first house at the top of the hill was the William Soesbe home. The same house still remains except it has been rebuilt.

Mr. and Mrs. Soesbe reared quite a large family, and two of their family were the Honorable Sam W. Soesbe and E. W. Soesbe who both studied law and be-

came prominent lawyers and bankers at Greene, in Butler county.

The Hon. S. W. Soesbe also served as state senator in the 23rd General Assembly from Butler and Bremer counties. The United States flag which hangs over every school house in the State of Iowa is there because of a law passed by S. W. Soesbe.

Going on up this Road of Fame one-half mile further past the Soesbe home is the school house where most of these boys got their first schooling. Across the Road of Fame is the same house where Dr. E. W. Lock-

wood was born and reared. He graduated from Rush Medical College in Chicago in 1875 and

was a prominent doctor and banker at Glidden. He married a girl at Olin, Sherilda Mershon, daughter of Noble Mershon.

On west 40 rods and just west of the late David Grassfield home, was a three room log house which was razed some years past. This is where Daniel Stutsman and wife lived and where their son, Henry H. Stutsman was born and reared. He was known as the world's greatest and finest penman with a national reputation. When I was in Los Angeles some time ago I saw an article in a magazine with Henry Stutsman's picture in which it said, "World's Finest Penman."

We go on west to the Fish House Corner where the first state fish hatchery was located. This fish hatchery was the first in Iowa and was established by an act of the state legislature in 1874.

B. F. Shaw of Anamosa was the first fish warden at that place.

Here at the Fish House Corner was a log and frame house where Israel and Sarah Luse lived. Mr. Luse was a Methodist preacher but was not ordained. They had four sons, Frank, James, Wil-

and John, all outstanding Methodist ministers and Frank Luse was the highest paid minister in the United States at the time of his pastorate as the head of the First Methodist Church in New York City.

We turn here on this Road of Fame at the Fish House Corner and go south 20 rods to the first place where a man by the name of Huber built the first house. He afterwards moved to Anamosa and was among the first school teachers and had much to do with our early school system. Later he was a judge in the Circuit Court. Huber Street in Anamosa, Iowa, was named after the late Judge Huber.

In the village of Fairview was the Fairview Academy which was not in the main part of the village but was in a suburb of Fairview. It was south on Sand hill in a three-story building which later was called the Darling House. Here was Milo P.

Smith who at the age of 23 resigned as teacher of this school and on the 18th day of May, 1861, walked to Lisbon, Iowa, and enlisted in the Civil War. He was mustered out as a major at the end of the Civil War and was later a Judge of the 18th Judicial District of Jones, Linn, and Cedar Counties, in Iowa.

In Fairview the brick house on the west side of this Road of Fame was known as the John Seerist home. John Seerist enlisted in the Civil War and became captain of the 13th Iowa Regiment, or better known as the famous Colonel Crocker Brigade.

Also on this road in the town of Fairview was the William Manly home. Here Wm. Manly and his wife, Ann, had 2 sons: the Rev. Ed Manly who passed away in 1952 at Helena, Mont., after being a missionary in West China for some 43 years, and Dr. Fred Manly, now of Phoenix, N. Y., who is a prominent physician and surgeon.

What a contrast meets our eyes every day. Truth and falsehood walked side by side down our street. Vice and virtue met and passed every hour of the day. The groan of the dying and the cry of the infant mingled together under the same roof.

The bridal party treaded close on the heels of the funeral procession and we also found Milo P. Smith at the south end of the Road of Fame teaching and dispensing education and good citizenship and the best for the welfare of mankind. At the other end of this Road of Fame we found old John Campbell with his saloon destroying the best in young manhood. These were some of the contrasts on this Road of Fame.

Dies After Illness

Mrs. Emma Lavina Stearns, widow of Charles W. Stearns, a Cedar Rapids resident for the last 23 years, died at her home at 1 p. m. Monday, following a long illness. *July 1947*

She was born Dec. 26, 1868, in Jones county and moved to Cedar Rapids from Lisbon in 1924. She was the daughter of Mr. and Mrs. Amos Kohl and lived with the exception of 23 years in the White Oak neighborhood, two miles from her parents' home.

Surviving are one son, Raymond Stearns of Lisbon; two sisters, Mrs. Tena Melton and Mrs. Minnie Fink, both of Cedar Rapids; four grandchildren, Mrs. Dorothy Siebels of Martelle, Mrs. Shirley Walton of Mount Vernon, Eugene Stearns and John Stearns, both of Lisbon, and a great-grand daughter Pamela Sue Walton, of Mt. Vernon.

She was a member of the United Evangelical Church.

Funeral services were conducted in the Turner Chapel at 1:30 p. m. Wednesday by the Rev. G. H. Bamford. Burial was made in the White Oak cemetery, seven northeast of Lisbon.

Charles W. Stearns died suddenly at the family residence, 534 Forest drive SE. at 6:30 a.m. Tuesday. Mr. Stearns was born March 18, 1861, in Jones county, and had engaged in farming all his life with the exception of the last ten years which were spent in Cedar Rapids. Besides his widow, Emma, he is survived by one son, Raymond Stearns, four grandchildren, Dorothy, Shirley, Eugene and John Dean Stearns, all of Lisbon; one brother, Earl Stearns of Springville, and one sister, Mrs. Charles Vaughan, of North Platte, Neb.

Funeral services will be held Thursday at 2 p.m. in the White Oak church, northeast of Lisbon, and burial will be in the White Oak cemetery. Friends may call at the family home after 10 a.m. Wednesday.

DIED: ARMENIA Y. BOWEN, on 30 Oct, aged 43 years and 10 months, wife of ASA C. BOWEN. At Sand Springs, Delaware county.

Armenia was born in Herkimer county N.Y. and passed her childhood and youth in that romantic locality of East Canada Creek, a few miles from its entrance into the Mohawk. There in the lap of nature, nursed by a christian household, was laid the foundation of that character which later years matured into unusual ripeness and richness.

In 1851 she came to Iowa as the bride of ASA C. BOWEN and settled at Bowen's Prairie Jones county, where for some 15 years she presided over household, garden and dairy with marked dignity and grace, as hundreds of guests can most truthfully and cheerfully testify. It is doubtful if any citizen of Iowa ever inducted more settlers or entertained more visitors than this pioneer family during the period mentioned. Our county fairs and in fact, all our public exercises and celebrations were aided materially and spiritually by her who is now no more.

JAMES J. WALWORTH, brother to C.C. WALWORTH, one of the early settlers in this place, and for many years past engaged in a brass and iron foundry business in Boston, Mass, lost a hundred thousand by the destruction of his branch house in Chicago, by the recent great fire.

14 OCT 1869

DESTRUCTIVE FIRE IN MONTICELLO
 "FIRE" cry rang out at 2:45 am, soon it was discovered the billard saloon on 1st street, owned by W.E. BERRY and occupied by WARRINER and MONROE, was one sheet of flame. All hope of saving this building was at once abandoned. The next building on the west was the store of McCORMICK & KENNEDY, which was a wooden structure, and stood only about a foot from the first named. With our inadequate fire facilities, nothing could be done towards saving it, and the crowd betook themselves to saving the stock. This was done. In 5 minutes, this building was wrapped in flames. The next was the drug store of Dr. N.M. SMITH & SON, which shared a like fate. Their goods were gotten out, though in a some what damaged condition. The Post Office stood next. After emptying it of its contents, the people, by means of ropes and hard work, pulled the building down--thus saving PEAK & WHITTEMORE'S and GILES BROTHERS' store. At one time it was thought that these must go, and the former now presents the appearance of having been pretty badly roasted. The brick building owned by DURHAM, MILLER & CONDON, on the east, was saved only after the most desperate exertions by our citizens, as also the residence and store of Mrs. C. DERBINS. The loses were:
 W.E. BERRY, saloon and fixtures \$2,500; insured for \$2,000.
 WARRINER & MONROE, stock in saloon, \$200; no insurance.
 McCORMICK & KENNEDY, store building and damage to goods, (con't next column)

probably about \$3,500; insured \$2,500.
 Dr. N.M. SMITH & SON, drug store, Post Office building and loss of stock \$2,500; no insurance.

PEAK & WHITTEMORE, damage to stock, unknown, but fully insured. GILES BROTHERS the same. Mrs. DERBINS the same. JAMES DAVIDSON, postmaster, loss about \$200; no insurance. GARDNER & DURHAM, damage to stock and building about \$1,700; fully insured.

This was the second great fire that has occurred here within a little more than a year.
